### Call to Order

OBX Aviation Ground Lease: Mr. Hinton informs the board that ECSU is purchasing the facility for \$248K and would prefer the lease to be rewritten in their name. The lease paperwork is currently with Angela at the property office being prepared, and County Attorney Mike Cox will review upon completion. Mr. Hinton states the lease terms and dates of the lease will not change; only the name. The lease will be available for motion during the April meeting, and will go to Council of State on May 7<sup>th</sup>.

#### Manager Report

Mr. Hinton reviewed the February fuel sales and informed the board that contract fuel is still pending. Mr. Hinton states we will need roughly \$10-14K in modifications to the fuel farm and he is currently looking at options to get that in place. Mr. Hinton has requested Eastern Aviation Fuels conduct our annual inspection next month in preparation for the contract.

Mr. Hinton informs the board Sun-n-Fun is the second week in April and he will be attending with a booth and would like to move our April meeting to the fourth Wednesday of the month due to the Aviation Conference scheduled.
